## BYELAW

Alumni Association of INDIRAGANDHI MAHILA MAHAVIDYALAYA, UDALA, MAYURBHANJ

Name- The name of the association shall be the "Alumni Association of INDIRAGANDHI MAHILA MAHAVIDYALAYA, UDALA, MAYURBHANJ", with abbreviation as AAIGMM, and its membership will be open to all past students and teaching staff of the college irrespective of their posting or residence anywhere in India or abroad. The organisation hereafter shall be referred as ' AAIGMM '.

Office -The office of the association shall be located at the premises of INDIRAGANDHI MAHILA MAHAVIDYALAYA, UDALA, Dist- MAYURBHANJ".

Aims and Objectives -The association shall be non-political and non sect aria in nature.

The principal aims and objectives of the association shall be:

- a) To provide forum for alumni of the college for a get-together from time to time and to promote social and cultural activities.
- b) To promote fellow feeling, patriotism, culture and environmental awareness in the students.
- c) To be of the service to the member, to college, the present student and to the society at large.

Activities-In pursuance of the aims and objectives of the associations following activities are proposed.

- i. Guide the students for professional and academic enrichment.
- ii. To grant free-ship Scholarships, Prizes, Monetary assistance, books and/or Stationery to the poor and deserving students, etc.
- iii. To provide career and vocational guidance to youth.

  - xii. To secure and manage a corpus fund for the promotion and fulfilment of the above aims and objectives.

Rules and regulations-

1. Membership- The membership of the association shall be open to any person who was a student of the college. In other words it shall remain open to all students who have done their Higher Secondary education, Graduation as a student of the college. - i) Subscribe to the aim and objects of the association
- ii) Apply in writing for membership in the prescribed form and pays the prescribed membership fee and other fees, if any, on admission by the executive committee.

## 2. Types of membership-

- a. **Life Member** -Any individual paying in one lump sum an amount of Rs. 1000/- or the amount as may be prescribed by the executive committee.
- b. **Honorary Member**-The executive committee shall have the right to elect an Honorary Member that any individual who has made an outstanding contribution to the society. While the Honorary member shall have the right to attend the general body meetings, he shall not have the right to vote.
- c. **Annual Member**-If any individual not paying fee of life member then he can pay the fee for Annual Member and become annual member. The fee structure for the Annual Members as follows:-  
For XII student Rs. 200/- BA. student Rs. 300/-

d. In addition to the above categories of membership the Principal of the college will be the Honorary Member of the Alumni Association.

### Note

A) The fee structure is subject to revision by the executive committee, if in its wisdom it becomes necessary in future.

B) The association shall maintain a register of members indicating the name and address of the member, type of membership and the date of enrolment.

## 3. Suspension and Termination of Membership-

The membership of any individual member, it shall be suspended or terminated if he is guilty of moral turpitude or a conformed criminal in the eyes of law, or his/her conduct is not in keeping with the accepted social norms, or has become insane, or has become insolvent. The executive committee suspend or terminate the membership of such a member with a approval of General Body only.

#### 4. Rights and Privileges

- a) Every member of the association shall be bound by the articles, rules and regulations of its constitution and by the decisions of the executive committee, taken from time to time.
- b) Every member of the association shall be entitled to benefits, rights and privileges provided by the association.
- c) A member of the association can request the executive committee to circulate amongst members any information if, in the opinion of the executive committee, it is of general interest and likely to benefit the members.

#### 5. Executive Committee

- i) The affairs of the association shall be managed by the Executive Committee, which shall consist of the following:
  - a) President..... One
  - b) Vice Presidents..... Two
  - c) Secretary..... One
  - d) Joint Secretary.... Two
  - e) Treasurer..... One
  - f) Eleven Members
- ii) The right to elect the executive committee shall rest with the general body of the association. The election to the executive committee shall ordinarily be held at the annual general body meeting for which the secretary, in writing, shall issue a three week notice in advance, to individual member.
- iii) The executive committee shall appoint an Election Officer who will conduct the elections in the Annual General Body Meeting. The election Officer will be independent of the executive.
- iv) If the number of nominations for any given office is equal to the number of posts, the election officer will declare the candidate as elected unanimously. If the valid nominations for a given post are more than the number of posts, election shall be held by count of hands in favour of the candidate, and the candidate acquiring more votes (hands) shall be declared elected.

v) If there are no nominations for a given office/post, the president on behalf of the executive committee shall propose a candidate who will then be declared elected to the post at the general body meeting, on getting his consent.

vi) **Term of Executive Committee**-The term of the elected Executive Committee shall be for a period of three years.

#### 6. Duties of Office Bearers

- a) **President:** The president shall preside over the executive committee meetings and regulate the proceedings. He shall supervise the administration and general affairs of the association.
- b) **Vice President:** In the absence of the President, the Vice President shall preside over the executive committee meeting(s) and conduct the proceedings. If both the President and Vice President are absent, the member of the executive committee can choose one among themselves to preside over the meeting.
- c) **Secretary:** The Secretary will maintain all records and carry out the administration work of the association under the overall supervision of the president/vice president. He will keep a record (minutes) of the proceedings of the executive committee meetings and general body meetings.
- d) **Joint Secretary:** The Joint Secretary will assist the secretary in all matters as and when necessary. In the absence of the secretary he shall carry out all the functions and duties of the secretary. In absence of the Joint Secretary the **associate joint secretary** will perform the duty of the joint secretary.
- a) **Treasurer:** Treasurer will be in charge of all funds of the association that will be deposited in a scheduled bank. It will be the responsibility of the treasurer to keep the account of all income and expenditure. The account of the association will be in the names of the members of the association and shall be operated jointly by the president, treasurer and secretary. However, at a time any two of signatories can operate the bank account. The treasurer shall not retain any cash in hand more than Rs. 100/- (Rupees one hundred only) and he/she shall have to deposit the fund in the account of the association.

- f) In case, the president ceases to function either because of illness or resignation or any other reason the vice president will automatically take over the functions of the president till the completion of the executive committee.

**7. Duties of the Executive Committee-**

- a) The executive committee shall meet at least once in four months. The quorum for these meetings shall be of 7 members.
- b) The executive committee shall have the following powers:
- i) To supervise the general administration of the association.
  - ii) To appoint committees or subcommittees this shall be directly responsible to the executive committee.
  - iii) To recommend to the general body such rules and regulations or amendments to the constitution as it may deem fit, but consistent with the aims and objectives of the association.
  - iv) To consider and approve applications for membership. The committee will not be bound to assign reasons for rejecting any application.
  - v) To acquire movable property through purchase or by way of donations for which proper record will be maintained.

**8. No Confidence Motion**

If there is a written request by at least ten percent members seeking no confidence motion against the executive committee on grounds of financial irregularity, moral turpitude, or any other act detrimental to the cause of the association, the secretary shall call for an extra ordinary general body meeting with clear 15 days notice in writing to all individual members fixing the date, time and place of meeting. The motion will be placed before the house for discussions followed by voting. For the motion to be adopted, a clear two-third majority amongst the members present will be required

10. **Dissolution of the Association**

If the circumstances warrant dissolution of the association, an extra ordinary General Body Meeting will be called to adopt such a resolution. The association will stand dissolved if the resolution is adopted by two third majority.

A meeting of the ex-students of Indira Gandhi Mahila Mahavidyala, Udala, Mayurbhanj, Odisha was held in the conference hall of college in presence of the principal Sashibhusan Panigrahi & other staff members.

It was attended by a good number of ex-students and conducted by the ex-student Depali Latika Jena of 1991-1993 batches. The ex-students of the college assembled to deliberate of the above mentioned agenda and resolved the following minutes unanimously.

1. The resolutions unanimously adopted in the previous meeting is read out by the convener and recapitulated. The same is confirmed by a common consent.
2. The Bye-law of the Alumni Association prepared as first proposal was read out before the forum. Everybody present there was apprised of its aims and objectives with proper clarification and explanation. All the schedules of draft proposal of bye-law were discussed and analysed in details. After deliberation the general body of the Alumni Association of I.G Mahila Mahavidyala, udala adopted the following resolution.
3. It is unanimously agreed that from this day i.e. 28.03.2024 Thursday the Alumni Association a body of old students of Indira Gandhi Mahila Mahavidyala will hold its function in the premises of the college. The aim is to provide forum of Alumni of the college for a get-together from time to time and to promote social & cultural activities, to promote fellow feeling, patriotism, culture and environmental awareness in the students and to be of the service to the member, to college, the present student and to the society at large.

4. It is further decided that the Alumni must have its own logo and a tag line i.e. "Empowered Women Empower Nation". This shall be a crest-type logo design. The idea behind this logo was to combine both the students and the association. In the enclosed space between the two circles will be given the name of the association, the year of its establishment. The combination of the people, trees and graduation cap images provide good description of the association and its core values. The tag line, EMPOWERED WOMEN EMPOWER THE NATION - aims at promoting women's sense of self respect, their ability to find out their own choices, and their right to bring about social change for themselves and others. It sends a clarion call to all join in its march towards perfection. The trees in the logo symbolise strength, individuality, expression, calmness, growth.

5. It is also unanimously agreed that the students who have once admitted in the college for a course and persued studies before leaving the institution can apply for membership. The membership of the association shall be open to any person who was a student of the college. In other words it shall remain open to all students who have done their higher secondary Education or Graduation as a student of the college. The membership shall also be open to the faculty members of the college if they were students of this college.

6. It is unanimously decided that the membership of any individual member, it shall be suspended or terminated if she is found guilty of moral turpitude or a confirmed criminal in the eyes of law or her conduct is not keeping with the accepted social norms or she becomes insolvent. The executive committee will suspend the membership of such a member with a approval of the General Body.

7. It is also decided that the right to select the executive committee shall rest with the general body of the association. The executive committee shall rest with the general body of the association. The executive body shall appoint an election officer who will conduct the election IN ANNUAL GENERAL BODY MEETING. The term of the elected executive body shall be for a period of 3 years of election. The secretary in writing shall issue a three week notice in advance to the individual member.

8. It is also decided that atleast 21 members assembled shall have a quorum to hold a general body meeting. The executive body shall consist of

- i. president - 01
- ii. vice president - 02
- iii. secretary - 01
- iv. Joint secretary - 02
- v. Treasurer - 01
- vi. Members - 11

➤ It is decided that the president shall preside over the executive meeting and regulate the proceeding. If both the president and the vice-president are absent the executive council can choose among themselves to preside over the meeting.

➤ The Secretary will maintain all records and carry out the administrative work of the association under the overall supervision of the president / vice-president.

➤ The Joint Secretary will assist the secretary in all matters as when it is required.

➤ The Treasurer will be in-charge of all funds of Association that will be deposited in a scheduled bank. It will be the responsibility of the treasurer to keep the account of all income and expenditure. The account of the association will be in the name of secretary and the treasurer of the association and shall be operated jointly by the treasurer and secretary.

9. It is decided that the principal of the Indira Gandhi Mahila Mahavidyala shall hold the office of chairperson of advisory board and he can nominate two to three members from the staff members of the college to its advisory board. On request the principal can preside over the General Body Meeting of the Association.

10. The attendees of the meeting agree that the Bye-law must be adhered to for the smooth function of the Association.

11. It is decided that the Bye-law of the Alumni association of IGMM, Udala in the district of Mayurbhanj and state of Odisha shall be documented as per the resolution adopted in this meeting. The principal of the college, experienced teachers named Manjula Kalia, Lect. in history, Sudharani Behera, Lect. in Home science, Dr. Sushama Sahoo, Lect. in Sanskrit, and Kshirod Ranjan Mohanty and some seniors ex-students and advocate S. Basanta Kumar Parida are requested to prepare the Bye-law of the association and get approved in the next General Body meeting.

12. It is decided that the Bye-law of the association will be registered at the register of Mayurbhanj, Baripada for its institutionalisation and preservation. Any legal compliances in term of Bye-law can be referred to the principal Indira Gandhi Mahila Mahavidyala for clarification.

The meeting was over with a vote of thanks to the chairperson.

A Meeting of the General Body of the Alumni Association was convened by the ex-student Ms. Deepalakshmi Jena on 22.07.2024 at 11.30 am. It was graced by the principal Sashibhawan Panigrahi and a few staff members. The above members of association attended the meeting and took part in the election of the new office bearers.

The following resolutions were unanimously passed.

1. The resolutions unanimously adopted in the previous meeting is read out by the convenor and reaccepted. The same is confirmed by a common consent.
2. Majority of members feel that the Alumni Association has been working actively since 2015 yet it has not formally been registered under Society Registration Act. So it is in one voice decided that a new executive committee shall be constituted to build a network of old students.
3. The General Body of the Alumni Association with a common consent have decided to nominate a new executive committee/council. The member of the first executive body shall be nominated by accepting the proposals from the member of the general body who are present in the meeting and such nominations have to be seconded or endorsed by the members. The proposal is unanimously passed.

4. The executive council of Alumni Association of IGMM, Udala, Mayurbhanj has been duly constituted with the following office bearers w.e.f the day of selection.

(a) The name and candidature for the post of the president of Alumni Association was proposed in favour of first batch degree pass out Ms. Deepalatika Jena by Hirabati Satpathy and the same was endorsed by Arati Gupta. All members accepted the proposal and Ms. Deepalatika Jena has been declared the president of Alumni Association of Indira Gandhi Mahila Mahavidyalaya, Udala, Mayurbhanj.
